Groups defending sex-based rights

An overview of some of the groups opposing sex self-ID in the UK. They have been set up by individuals and collectives concerned by the failure of established third-sector organisations to defend women's sexbased rights, child safeguarding and evidence-based policymaking. Although a few have a handful of paid staff, they rely almost entirely on small donations and volunteers' time.

Woman's Place UK (WPUK)

- Grassroots feminist campaign formed in 2017 by women with backgrounds in trade-union and broader social movements.
- Aim was to ensure women's voices would be heard in the consultation on proposals for selfidentification and to uphold single-sex exceptions.
- Played a large role in getting government plans to reform the Gender Recognition Act abandoned in England and Wales, then evolved into a broader women's rights campaign.
- Public-facing work includes meetings on women's rights the harassment these meetings has attracted has been instrumental in raising awareness of the tactics used to silence women speaking about their sex-based rights.

- Campaigning and consultancy group which raises awareness, provides evidence and analysis, and supports policy-makers to protect the rights of women and girls in the UK.
- Opposes sex self-ID, and played a large part in the government's decision to abandon plans to introduce it in England and Wales in 2018.
- Brought the judicial review in 2021 that forced the ONS to continue to collect data on sex in the
 census, rather than conflating it with self-declared gender identity.
- Has specific expertise on the harm done to women by allowing males to participate in female sports and to apply for transfer to female prisons.
- Director is Dr Nicola Williams.

- Not-for-profit organisation set up in 2021 with a singular mission: to re-establish that sex matters in rules, laws, policies, language and culture.
- Executive director is Maya Forstater, who in 2019 took a case in the employment tribunal after losing her job for talking about sex-based rights.
- This led to a precedent-setting ruling that the everyday understanding of human sex as binary, immutable and important is a protected belief under the Equality Act.

- Registered charity set up in 2019 to advocate for the rights of gay, lesbian and bisexual people.
- Founded by two lesbians, Bev Jackson (who in 1970 was a founding member of the UK Gay Liberation Front) and Kate Harris (who was formerly an active supporter of, and fundraiser for, Stonewall).
- Supported by Aubrey Walter, one of the founders of the UK Gay Liberation Front, and by many former champions of Stonewall, who see it as the heir to the early gay and lesbian rights movement.
- All the other groups that used to support LGB people have switched their attention to the promotion
 of gender-identity theory, which LGB Alliance regards as regressive and homophobic.

- Founded in 2015 to draw attention to the harms done by gender-identity ideology to children, especially in schools and in medicine.
- In 2020 was given permission by the High Court to intervene in support of Keira Bell's judicial review
 against the Tavistock & Portman NHS Trust. In March 2022, the Interim Report by the independent
 Cass Review into the Tavistock Gender Identity Development Service vindicated Transgender Trend's
 stance.
- Director is Stephanie Davies-Arai. In 2022 she was awarded the British Empire Medal as founder of Transgender Trend for services to children.

- Focuses on children, specifically on safeguarding and the correct interpretation of the Equality Act.
- A group made up of parents and professionals that produces resources to support parents who seek
 to challenge harmful school materials and policies that prioritise sex self-ID over the privacy, safety
 and dignity of all children.
- Played an important part in judicial challenges to "trans inclusion guides" that went against childsafeguarding principles that resulted in several such guides being withdrawn.
- Chief spokeswoman is Tanya Carter.

- International alliance founded in 2021 by parents and clinicians seeking a rational approach to gender issues.
- Has expanded to include detransitioners, desisters and people unhappy with their own transition, as well as other professionals such as educators and journalists.
- Creates resources on gender issues and seeks a better approach to the diagnosis and treatment of gender dysphoria and greater awareness of the role played by healthcare and education establishments in funnelling vulnerable children towards a singular, and potentially harmful, solution to gender distress.
- Partners with grassroots group PITT Parents with Inconvenient Truths about Trans.
- UK spokespeople include Stella O'Malley, a psychotherapist who specialises in counselling families
 dealing with gender-distressed children, Claire Graham, an expert on differences of sex development
 (DSDs, sometimes misleadingly described as "intersex" conditions) and Ritchie Herron and Sinéad
 Watson, both detransitioners.

- Group of clinicians concerned at established medical bodies' and regulators' uncritical support for experimental treatments for gender-confused and gender-distressed people. (For names of members, visit the website.)
- Advocates for clearer dialogue, better data collection, rigorous science and improved treatment options for gender dysphoria.
- Calls upon healthcare organisations to develop evidence-based policies for data collection and single-sex spaces, with clear definitions of biological sex and gender in accordance with the Equality Act.

- Founded in 2021, a group of psychotherapists and counsellors who campaign to raise awareness of the negative impact of gender ideology on mental-health services, in particular for children with gender dysphoria.
- Work has focused on government proposals to ban "gender-identity conversion therapy" and on the "Memorandum of Understanding on Conversion Therapy" signed by many health and therapy organisations.
- Fears both of these risk undermining exploratory therapy for vulnerable children by pushing an "affirmation-only" treatment model for gender distress.
- Main spokesperson is James Esses.

 Declaration setting out the sex-based rights required for women and girls to flourish. The Declaration
 has since been signed by thousands of Labour-voting supporters, including elected politicians (Peers,
 MPs, MSPs, Cllrs) and Constituency Chairs and women's officers.
- Campaigns within the party and wider socialist movement in support of women's sex-based rights, for evidence-based policies on sex and gender, and for free speech to discuss these.

- Landmark court ruling in 2021 that it was unlawful for the Scottish government to redefine the word "woman" in legislation about female representation on company boards, and polling suggests that Scottish people are against redefinition.
- Directors are Trina Budge, Susan Smith and Marion Calder.
